Zsaquez Flucker serves as the Assistant Program Director of the GLEAMNS Community Services Department, but she didn't start off that way. Zsaquez first came to GLEAMNS when she was laid off in 2009 due to the recession. She had heard about a part-time position with the agency and was hired in February 2009 by then GLEAMNS COO Ron Davis to be the Activities Coordinator for the GLEAMNS Department of Juvenile Justice (DJJ) Teen After-School Center (TASC) Program, currently known as the TASC Program. Few months later, she transitioned to the GLEAMNS Workforce Investment Act (WIA) Department as a temporary fulltime summer youth counselor. In August 2009, she joined the Community Services Block Grant (CSBG) Department as a temporary full-time case manager through the American Recovery and Reinvestment Act (ARRA). She was eventually hired by the CSBG Department to be permanently on staff, working as a case manager in Newberry County, Greenwood County, and Saluda County, respectively. As a case manager, she was cross-trained to handle applications in both the Community Services Block Grant (CSBG) program and Low-Income Home Energy Assistance Program (LIHEAP). In 2016, she was promoted to her current position. In her years with the agency, she received the Staff of the Year award in 2012 from the South Carolina Community Action Partnership (SCCAP) and became a Nationally Certified ROMA Trainer in 2018. She has also served on the GLEAMNS Newsletter committee and is responsible for several publications aimed at promoting the impact of Community Action, including e-newsletters for Community Action Month and more.

The GLEAMNS Community Services Case Management program is designed to provide educational and transportation assistance to socio-economically challenged adults in becoming self-sufficient and improving their quality of life. Case Management provides a support mechanism that helps individuals to obtain education beyond high school or prepare individuals to become marketable in the work place. Assistance may be available according to needs, as in tuition, uniforms, books, classroom supplies, and driver's training.

EDUCATION

The following customer enrolled in Case Management for educational assistance and became a success story!

Edgefield Customer Transitions from Part-Time Sitter to Full-Time C.N.A.

Andrea Leaphart enrolled in Case Management on August 23, 2018 for assistance with the Certified Nursing Assistant (C.N.A.) course at Lifelong Learning Center in Batesburg-Leesville, SC. After completing the course in December 2018, Andrea took the C.N.A. certification exam in January 2019, and she passed to become a Certified Nursing Assistant. Upon her enrollment in Case Management, Andrea worked part-time as a sitter on the weekends for the

Ridge Rehabilitation & Healthcare Center in Edgefield, SC. However, right after receiving her C.N.A. certification, she transitioned to working full-time as a C.N.A. for her employer! Andrea enrolled in Case Management with the desire to transition to a higher paying job, and she did it in less than six months! GLEAMNS assisted Andrea with the cost of the C.N.A. program, uniforms and supplies for clinicals, and the cost of the C.N.A. exam.

TRANSPORTATION

As part of a component under the Case Management program, the GLEAMNS Community Services Department offers assistance with driver's training. This facet was created in response to a transportation issue of customers lacking a learner's permit and/or driver's license. Thus, eligible individuals can enroll in Case Management to receive transportation services, such as classroom instruction and road testing, to obtain their beginner's permit and/or driver's license.



Here's a quick refresher of what it is and why it's essential that everyone is counted.

Everyone counts.

The census counts every person living in the U.S. once, only once, and in the right place.




It's about fair representation.

Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.




It's in the Constitution.

The U.S. Constitution requires a census every 10 years. The census covers the entire country and everyone living here. The first census was in 1790.



It means \$675 billion.



Census data determine how more than \$675 billion are spent, supporting your state, county and community's vital programs.



It's about redistricting.

After each census, state officials use the results to redraw the boundaries of their congressional and state legislative districts, adapting to population shifts.
